Good Journey trains youth leaders to grow more than 30 vegetables and fruits, fruit trees, herbs and flowers, and learn to prepare healthy meals and more. Bustani Ya Upenda (Garden of Love) is in the Academy-Sherman Park Neighborhood in St. Louis City. Students and young people of all ages work with their families and neighbors to grow food for and with the community, gaining skills in community development.

A multi-week summer program that engages youth in academic enrichment, community projects, culture and arts projects, educational field experiences and fun and engaging activities that teach communication, life and leadership skills. Youth present values of collective work, responsibility, and unity to the community after the conclusion of their Summer Leadership Academy experience. Participating youth have demonstrated practiced entrepreneurship through the creation and selling of tea, art, and technology devices they developed. Youth demonstrated an understanding of positive contribution to community by volunteering in the garden. Youth further contributed to the beautification of the community through poetry, murals and more.

LIVE Black Youth Corps utilizes Good Journey's innovative organizing model-LIVE-Leaning Into Value & Equity. LIVE Black Youth Corps is Black youth empowerment through the eradication of internalized racism and inferiority; understanding the history of racism and where we are today; building strategies to address internalized inferiority of Black peers and authorities in youth spaces; building strategies to address internalized superiority of white peers and authorities in youth spaces; adult community advocate support training; organizing a movement for change; expressing self and community care in racist moments; building resiliency and operating to resist and change systems; and building faith in self, community and a movement. LIVE Black Youth Corps includes Black youth from middle school to age 21 who have been affected by racism in youth spaces that should be safe for them and their peers. This project prepares and supports several corps of Black youth as they organize and advocate for racial justice.

A multi-week program in which young people explore trauma, oppression, emotions, and build skills in resiliency, self and community care, and the ability to positively project internally and externally through the creation of art. The artist guides young people in their work through 25 sessions and 8 art projects that speak to who they are and what they feel. The partnering counselor helps young people learn to communicate their experiences to reinforce and build upon their humanity to create space for healing. Xpress U Thru Art youth make healthier life choices and develop as leaders.
